



## **Evolution End of Year Procedures 2022**

Procedure: EDG-003

## **Summary**

The most important thing you need to do before starting your end of month routine, and specifically before running your Broking End of Month for June, is to ensure you have setup your General Ledger Next Financial Year Period Table.

Year End in Evolution is a relatively simple and automated process. The Broking System does not have any special year-end processing. The end of the financial year only affects the General Ledger.

Some important things to remember when running the General Ledger year-end is that this process can only be run once. The year-end process will calculate and post the retained earnings journal for current year profit and it will the roll the Period 12 balances for the old year to opening balances in the new year for the Balance Sheet Accounts.

For the last month of the financial year, we recommend that you run End of Day and End of Month, but do not run General Ledger End of Period and End of Year until you have completed reconciliations and journals for that month. Note, however that until the General Ledger End of Period is run the existing period will remain open and it will be the default posting period.

If you have a multi currency system and use foreign currencies, additional steps for Revaluations and manual Profit and Loss appropriations are required. Contact Ebix Support if you require assistance with these procedures.

Note: The procedures described below apply for companies with a 30<sup>th</sup> June financial year end. Clients with a different end of financial year should adapt the procedures described to their respective year end date.

As always no one should be logged in Evolution when running these processes.





#### 1.0 Period Table

1.1 The Period Table defines posting periods for the current, prior and next financial year. It allows you to define the number of accounting periods (the default being twelve) and the dates for each period.

If you haven't already done this you must Create the Next Financial Year Period table – we suggest that you call the year 2023 with July being the first period of that year.

- 1.2 Ensure that the first period, (ie Period 01 / 2023) is Open.
- 1.3 Also ensure that one period, typically Period 12 / 2023 is marked as End of Year.

#### 2.0 Broking System

The Broking System does not have any special year-end processes and therefore you just run your normal End of Day and Broking System Month End processes and complete the normal checks and reconciliation's.

### 3.0 General Ledger

- 3.1 Complete all period 12 (June) transactions
- 3.2 Post any un-posted batches within the General Ledger
- 3.3 Run a General Ledger Trial Balance and a Postings Print Report
- 3.4 Run a full Evolution system back up. \*\*\*\*\*IMPORTANT\*\*\*\*\*
- 3.5 Run a General Ledger Period End for Period 12
- 3.6 Immediately after running the Period End run the Year End Process
- 3.7 Year End Process
  - > General Ledger Menu
  - > General Ledger Utilities Menu
  - Year End
- 3.8 Following Year End run a General Ledger Trial Balance. The Opening Balance on this report should equal the Closing Balance from the report run in step 2. If these balances do not equal call Ebix Support.
- 3.9 Check the following Evolution dates.
  - The General Ledger current period in the period table should be 01 2023.
  - Check the Company record. The End of Month Date should be 31.07.2022. The End of Year Date should be 30.06.2023 for a July to June financial year
  - On the General Ledger Control Panel check the general ledger posting period. This should be 01 2023

If all of these dates are correct then you are ok. If not then call Ebix Support.
