Integrating e-commerce facilities on your web site and reducing back office costs is now easier with the introduction of the Ebix Online Payment Gateway (OPG).

Ebix OPG is a standalone module providing an easy to implement e-commerce facility allowing your clients to pay for their policies online in a fully secured environment.


In addition to payment flexibility, the module will attract clients to your website increasing its marketing potential.

Online Payments

Ebix Online Payments adds immediate flexibility for your clients by allowing them to pay online using debit, credit, or newly added, PayPal. The module can be added to your existing web site, allowing your clients to easily pay invoices without the need for any manual intervention or processing. Simply direct clients to the online payments page on your web site and let them nominate whether they are paying an individual invoice or their total outstanding balance.

The Online Payments module manages payment verification by checking that transaction details are correct before the transaction amount is passed to a financial institution for processing. The verification process confirms that the client and invoice number is valid. The Online Payment Module will then display the amount outstanding for that client or individual invoice eliminating any possibility of incorrect payment allocation.

Details of payments processed by your nominated financial institution are then uploaded into your

CBS, eGlobal, Evolution or WinBEAT system negating the need for manual receipting.

The benefits are instantaneous – more flexibility for your clients, less manual processing and improved cash flow.

These financial institutions offer support for payments by major credit cards. You can choose the most appropriate financial institution for your transaction volumes and one that offers services and fees to match your specific requirements.

Automatic Processing

Details of all payments made using the Online Payments module will be communicated back to you by your financial institution. Methods of communications differ by organisation, some emailing payments files daily, others making them available for collection from their secure web site.

Once the payment file is received it can be automatically processed by the CBS, eGlobal, Evolution, or WinBEAT Automated Banking module.

Payments are automatically matched to the correct invoice eliminating the possibility of receipting errors.

Eliminating manual receipting reduces back office costs and allows staff to utilise time more productively.

Modern Design

The default layout of the payment gateway is clean and minimalistic

allowing it to blend into your website easily.

Design elements such as company logos, colours and fonts can be customised to suit your branding.

OPGView

A recently added feature, OPGView allows your finance administrators to login in and view the entire OPG payment history log. This assists in resolving any payment queries should these arise. Using OPGView your finance team can establish whether a payment has been accepted or declined. Payments can be searched by invoice and client reference numbers.

OPGView payment logs can be viewed in detail to see exactly how much was paid, the reason for a decline in the event a payment was declined, customer email details and the bank transaction ID number. OPGView assists with the payment administration, resolving most payment queries quickly and efficiently.

System Requirements

The Online payments module is supported in our CBS, eGlobal, Evolution, and WinBEAT products.

Ebix OPG is an optional module available under licence from Ebix. Payment Gateway functionality may vary by financial institution.

Environment

The Ebix OPG module is hosted by Ebix and requirements are as follows:

- IIS 10.0 under .Net Framework 4.8
- An SSL Certificate for the applicable domain name, supplied to Ebix
- A secure port connection between OPG and the Ebix Broking System server.
- A new Web Service will need to be installed on the appropriate server connected to your Broking System. This is for OPG to validate references and return the outstanding balances.
